Mayor and council members,

Badass Brews LLC is requesting an alcohol open container permit for July 29th, August 5th and August 6th.

The event we will be doing on July 29th will be a "show off your ride" car show. We will be requesting the road to be closed from Flaming gorge wy to railroad on N 1st E so that people can display their vehicles for show. We will be providing music and adult beverages to participants and spectators. Goats restaurant will be on site for our food vendor. The time of the event will be 10AM thru 6pm at which time we will remove the barricades and set them off to the corner of our building for pickup. the road will only be closed for the period stated above.

The event on August 5th and 6th will be "Too broke for Sturgis" and will be a small motorcycle rally for the people of the county and surrounding areas that can't make it to Sturgis this year. We are planning a poker run, music, outside activities and a few vendors if we can get them to commit. We are asking the state for permission to close Flaming Gorge way between Center st and N 2nd E to accommodate the rally but will also be asking the city to close N 1st E in case we are unable to close the main road thru town. We are asking for an open container permit for this rally between Badass Brews and Buck N Bar as we will be working in conjunction on this event. The hours of the event will be 10am thru 11pm both days.
